I, the undersigned, parent/guardian, assume all risks and hazards incidental to participating in the activity and do hereby waive, release, absolve, indemnify and agree to protect, defend and hold harmless R.E.A.L. Kids Family Salon and Day Spa, their owner, staff and participants for any claim arising out of any injury to myself/child to the fullest extent allowed by law. I, the undersigned, parent/guardian of the participant, am fully aware of the potential dangers and risks inherent in this activity, including physical injury, death or other consequences that may arise or result directly or indirectly from participation in all Salon and Spa activities.
